# Discussion of letter from Craig Merrill, MD, regarding Woodlands/Monarch Dunes.

Dr. Merrill wrote letter of concern with tree removal on land originally designed to accommodate third golf course (though Shea homes, contractor for Monarch Dunes, is applying for Specific Plan Amendment to allow alternate use). Dan Garson, Representative of Monarch Dunes LLC, explained trees had been permitted for removal. Since Dr. Merrill does not reside in Monarch Dunes, has no vested interest, and did not attend the meeting though notified in advance, no action was taken

## Revisitation of concerns raised at March LUC meeting

Nursery on Mesa Road – Istar to contact Brian Pedrotti, Planner, for more information New building on Tefft identified as a combination residential /commercial development had been approved many years ago and is now under construction.

Strawberry fields on bluffs – Richard Wright gave report on issue. Approximately 25 of a total of 50 acres of "Open Space" in original development has been purchased by a Strawberry farmer for crop production. Neighbors are very concerned with request, loss of trees, and change from the primary belief that the wooded natural setting was designed to be permanent. Residents believe any change would reduce property values. This also raises questions concerning the County allowing commercial crop production in a residential rural zone. A Neighborhood meeting is scheduled for Thursday, April 16th for the County to meet with the residents to discuss the options.
