MEETING MINUTES Cont' Monday, October 24th, 2016

Correspondence and comments from the chair -

Chairman reads the following statement "The SCAC provides a forum for citizen involvement and information on issues affecting unincorporated areas in South SLO County. The objective of the SCAC is to advise County Government entities on those issues." Art Herbon also spoke very highly of the recent Community Advisory Council training provided by the County.

SLO Board of Supervisors – NOT PRESENT

SLO Sheriff's Office – Sheriff John McDaniel stated that there were 767 calls for service as of October 1st; 30 arrests with nine for narcotics, 10 burglaries/vandalism and answered questions about the recent raid of the marijuana grow at Clearwater Nursery.

California Highway Patrol – Officer Mike Brown provided an overview of CHP policies and capabilities. NCSD – Dan Woodson discussed the automated meter reading proposal to NCSD; that the pump station is now 50% completed and that the lift station at Division/Story and Lois Lane was in need of repairs.

Nipomo Chamber of Commerce – David Nilsen stated that luncheon on Thursday would include information on the Dana Adobe Cultural Center and the Skate park project. He also stated that the Installation Dinner is scheduled for the 19th of January.

Lucia Mar Unified School District – Vern Dahl – Introduced the new principal for Central Coast New Tech High. Christian Holst helped start the school in 2012 and stated that they have a 100% graduation rate and that 50% have gone on to four year institutions and that the other 50% have gone on to two year programs. He also stated that 13% of the students at New Tech come from out of the District.

SLO Planning Department – Stephanie Fuhs stated that the Laetitia Reserve project was denied on appeal to the BOS and that the Phillips 66 Rail spur was denied at the planning commission and is now on appeal to the BOS.

Public Comments – Public testimony on items not scheduled on today's old and new business. Speakers are allotted 3 minutes for comments (total time for public comment is 15 minutes)

Istar Holliday stated that she believed the Phillips 66 appeal was timed to coincide with the Supervisor elections in the hopes that two supervisors would be replaced. She further stated that she believes the rail lines to be dangerous.

Art Herbon stated that the recent Trilogy Harvesting for Hope fund raising event raised \$43,000 for local charities

DRC2016-00005, GHAZALY SOUTH COUNTY E-REFERRAL, 1020 DIVISION STREET, NIPOMO PROPOSED MIX USE DEVELOPMENT: 8,200 SQ. FT. COMMERCIAL, 4,800 SQ. FT. STUDIO APARTMENTS. Christopher J. Horstman, Michael Peachey and George Ghazaly corrected a number of issues with the previous referral. He has changed the number of buildings from four to six and stated that they are in possession of an intent to serve from NCSD for sewage and a Will Serve from Golden State.
