- 3. DRC2019-00020 Phillips 66 Pipeline LLC Project https://www.slocounty.ca.gov/getattachment/abd98885-ae42-4bcc-a87f-2ff56bcb62cd/DRC2019-00020-PHILLIPS-66-Referral-Package.aspx
 - 3.1. Relocation and replacement of crude oil pipeline from Santa Barbara County locations, to the Phillips 66 Refinery. The project adds 5 miles of heated pipeline in SLO County. It travels east of the Phillips 66 facility on Battles Rd in Santa Maria, then north-west in agricultural areas to the refinery. Phillips 66 Pipeline LLC is a Common Carrier. Condemnation proceedings can be used to acquire right of way easements. The old pipeline that travels north along Highway 101 to the summit area near Los Beros Rd. will be mothballed, by cleaning it out and filling it with nitrogen under pressure. Phillips 66 personnel stated that it will probably never again be used to transport crude oil. Land Use Committee voted unanimously to place the project on SCAC Consent Agenda.

 - 4.1. Conditional Use Permit for 20' x 20' fenced area to accommodate an 80' Mono Eucalyptus cellular tower and related equipment at 256 North Oakglen Ave. in Nipomo. Jesse Gilholm of Synergy Development

Services, Inc. presented the project to the Land Use Committee. The site is near the Lucky Dog kennel; the owners are aware of the installation of the tower. The applicant claims that negative health effects of the cellular tower diminish to less than 5% of the Federal allowable, at a distance of about 50 feet from the tower. The Land Use Committee questioned whether the appearance of the tree could be improved, but voted unanimously to place the project on the SCAC Consent Agenda.

 - 1.1. Two Minor Use Permits for indoor (greenhouse) and outdoor cannabis cultivation on Thompson Rd Ave (near intersection of Highway 101 and Highway 166) in Nipomo. The applications cover two parcels that are contiguous with same ownership. They are located northeast of Hwy-101 and Hwy-166. Odor doesn't appear to be an issue for agricultural properties southeast of the project. The property is currently used to graze cattle. The applicant claims there will be no increase in water usage compared to agricultural crops (avocados and lemons) grown in adjacent properties. The facility will have 8 full time employees, and up to 11 employees at the height of growing season. There will be a security system that meets the requirements of the SLO County Sheriff.

 - 2.1. Conditional Use Permit for 22,000 sf cannabis cultivation; 5,250 sf cannabis nursery; and 3,000 sf building for cannabis manufacturing at 3785 Mehlschau Rd. in Nipomo. Presentation was made by Jessica Edmondson of Kirk Consulting. Land Use Committee suggested that the applicant get letters from neighboring residents indicating their feelings about the project, since the project is in close proximity to residences and to schools. Project would use 1.18 acre feet of water per year, compared to the 25.5 acres feet of water used previously. The project also includes awater tank, fire suppression system and security system, with a maximum of 8 employees. Odor emissions would be eliminated with a Fogco carbon scrubber system.
