 - 2.1. The following items were discussed at the Land Use Meeting:

- 2.1.1.Gill Rodrigus project architect.
- 2.1.2.15-16 letters sent out to neighbors. Neighbors on each side have written letters of approval. Committee asked which neighbors (Gilbert Herrera and ?) recommended approval.
- 2.1.3. Applicant knows that odor is a problem, and has requested the county to approve setbacks that are out of compliance. The applicant claims odor will be mitigated with a six foot tall solid fence. Applicant also discussed planting Jasmine or Lavender (to improve odor?).
- 2.1.4. Property is 30 acres, 835' x 1920'. 3 to 6 employees.
- 2.1.5. Basically a distribution center w/ cargo vans.
- 2.1.6. Composting on site
- 2.1.7. Harvest 3 crops per year (every 10 weeks)
- 2.1.8. Applicant was asked if they were aware of litigation in Carpinteria regarding problems with nearby crop pesticides.
- 2.1.9. Many high dollar houses on the east hills (gated community) may complain loudly about smell.
- 2.1.10. Property previously used for cattle (no previous water usage?).
- 2.1.11. Land Use Committee voted to have hearing at SCAC meeting
