# **Approved Change to August SCAC Agenda**

## **Expansion of Item 8 under new business**

The Traffic and Circulation Committee has always expressed concern about the inclusion of another access means from South Oakglen to 101. In concept, Road Impact Fees are designed reduce traffic problems created by development generated traffic. In the case of Oakglen/101 there is no existing traffic problem. In fact, allowing this access could very well develop a traffic problem. There are many other traffic issues in this community that need correction before the Oakglen Secondary Access deserves consideration.

The Committee voted unanimously to recommend that the SCAC not recommend approval of the 2019 *Update to the South County Circulation Study* until the wording regarding the Oakglen Secondary Access is removed from the resolution. It is requested that the SCAC follow suit.
