## PROJECT NUMBER & NAME: DRC2019-00203 AT&T (Marsalek) PROJECT

<u>DESCRIPTION\*</u>: Proposed Conditional Use Permit for a telecommunications facility / cell site consisting of a 75' high mono-eucalyptus antenna and ancillary antenna panels, and ground-mounted utility cabinets/ equipment. Location is 154 North Oak Glen Avenue in Nipomo. APN(s): 090-151-010

PROJECT NUMBER & NAME: SUB2019-00080 CO 19-0078 GLOTOV PROJECT

DESCRIPTION\*: Proposed 4-Lot Parcel Map on existing 4.77-acre lot with new private access road. Parcel was the subject of a previously approved 3-lot tentative parcel map under SUB2018- 00025/CO 18-0042; applicant now has additional water for a fourth parcel. Location is 750 Sandydale Drive in Nipomo.

## PROJECT NUMBER & NAME: SUB2019-00079 TR 2656 KIES PROJECT

<u>DESCRIPTION\*:</u> Proposed Tract Map Amendment to expand current building envelope to facilitate development (single family residence, accessory dwelling unit, and metal building) at 171 Cimarron Lane in Nipomo. APN(s): 090-042-055 (parent parcel is 090-042-017)

PROJECT NUMBER & NAME: DRC2019-00069 Union Oil of California PROJECT DESCRIPTION: A request by Chevron Environmental Management Company to amend an existing Conditional Use Permit (D890558D) for remediation activities at the 2,700-acre Guadalupe Oil Field located west of Highway One and north of the Santa Maria River in southern San Luis Obispo County (2184 West Thornberry Road in Guadalupe. The applicant proposes to construct an 18.2-acre, onsite, Treated Soil Management Area (TSMA) for the treatment of contaminated soil that is excavated from various areas within the oil field. The TSMA is designed to contain approximately 1,185,500 cubic yards (cy) of petroleum hydrocarbon (TPH)-affected soil. In July 2005, the County Planning Commission approved an amendment to D890558D allowing the applicant to dispose of TPH-affected soil at the City of Santa Maria Landfill. With this project the offsite trucking of TPH-affected soil would be discontinued as the primary soil disposal method. APN(s): 092-041-001, -003, -004, -005, & -006; and 092-051-002
