Community Presentations:

SLO Sheriff Sgt Hernandez reported 834 total calls in May 2025, down slightly from 859 in 2024. There will be some use of drones to help locate illegal fireworks this year.

CHP Lt. Ferguson reported on current statistics, highlighting numerous crashes and hit and runs and the potential effectiveness of front and rear dash cams in investigations. During their recent maximum enforcement period there were 225 stops, 185 citations, and 8 DUI arrests, and there will be another MEP July 3-6 with 80% of their officers on duty during that time.

Consent Agenda: Minutes from 5/27/25, the Treasurer's report, and development project C-DRC2025-00014 were approved as presented (Walls / Vines / unanimous).

New Business:

Monarch Dunes Tentative Tract Map N-SUB2025-00029: after the representative's presentation and discussion of parking, trails, and water source for irrigation, the council voted to recommend the project's approval as submitted. (Girard / Wachsmuth / unanimous)

Barca Farm to Table Market <u>N-DRC2025-00018</u>: after the representative's presentation and positive appearance comments from council members and attendees, the council voted to recommend the project's approval as submitted. (Spelbring / Morales-Board / unanimous)
