## **Community Presentations:**

**CHP Lt. Ferguson** reported on current statistics, highlighting numerous crashes including 1 major injury, 7 minor injury, and no fatalities. There were 5 DUI crashes and 19 arrests. He stated they are working to reallocate staffing based on higher issue areas/times. He also provided clarification between black/white speed limit signs, which are regulatory and enforceable, versus yellow signs which are only advisory.

**John Joyce, NCSD**, reported on upcoming rate increases of 13.8% for each of the next three years based on ordered water acquired from Santa Maria but without current customers to buy it.

## **New Business:**

McKenna residence MUP N-DRC2025-0035: after the representative's presentation and discussion of energy efficiency, roof pitch, solar panel location, fire department turnaround, storm water drainage, clearing and fire-hardening of vegetation, and light pollution standards, the council voted to recommend the project's approval as submitted.
