Dan:

Here is our very simple position:

*The Home Builders Association fully supports paying for all the traffic and other infrastructure improvements that are necessary to provide public services to new construction.*

*We also fully recognize that traffic problems exist today in Nipomo and contribute to public opposition to new development.*

*Our traffic impact fees in Nipomo have risen almost 100 % in the last three years without any corresponding improvement in community traffic flow. We don't believe the community will see traffic improvements if the entire solution is left for new construction to fund. There isn't enough development to fund fixing yesterday's problems, today's and tomorrow's.*

*The Home Building Association is very interested in working with the community to help fix existing problems and to assure that new construction doesn't aggravate the situation. However, any extra contributions we make toward fixing problems we didn't cause must make financial sense and will require changing how the county administers the growth management ordinance in Nipomo.*

*The South County Area Traffic Update needs to be presented in context with a financing plan that will actually figure out what improvements are needed, exactly how they will be funded, and when will they must be built.*

*We will continue to participate in the Traffic Committee meetings as a resource for its members and to explore ways to make things better for all.*
