Traffic and Circulation Committee Meeting Thursday, October 19th at NCSD, 148 South Wilson 9:00 to 11:00 am

- 1 Update on South Grontage Road Realignment Project (Grande to Tefft Street); King Ventures and Nipomo Commons Road Improvement Agreement with SLO County.
 - At a recent meeting County Staff requested a 75-foot turn pocket for freeway access. Dave Watson has agreed with this and hopes to have the agreement finalized by the end of the year. Ted Moore has executed his agreement with the County. CalTrans may have an issue with the one-way aspects of South Frontage during construction.
- 2 Blackhawk/Hazziez/Nopal/Giz/Higos shortcut from Division to Grande, response about speed bumps. County sent Speed bump info to people at the wrong end of this configuration. Colette Hyder will hand carry information and petition to local residents.
- 3 Porthea Cange School is apparently regulating parking on Mesa View, is this allowed?

 Dale Ramey indicated that it is not the prerogative of the school to unilaterally regulate traffic on County roads. Dale, the Sheriffs Office and Code Compliance are investigating right-of-way encroachments and paving and drainage issues on Osage between Tejas and Los Flores forcing children to walk on the paved portion of the road. Committee supports this endeavor. Dale will consider Safe Routes to School grant to help out this situation.
- 4 Has the Teffit meridian contract been renegotiated or rebid, what is the funding source
 Engineers estimate was 110K\$. Bids came in at 200K\$. Expenditure
 authorization must come from a higher level of Von's management. Dale
 will keep us updated so a press notification can be made.
- 5 Consider speed limit sign on Hettrick
 Dale will consider a speed advisory sign.
- 6 In several locations throughout Nipomo there are abandoned construction signs that need to be removed Inform Dale about the location of the signs.
- 7 TGCC requests eleven bound, loose leaf, final copies of the Traffic Report. One of these copies shall be designated for the Cibrary. Report cover should indicate dates of report coverage and date for next 5-year report. Inside page should include stamp and signature of an individual licensed to practice engineering in the State of California

8 Both, the Traffic and Circulation Committee and the South County Advisory Committee have asked that there be no further expenditure of Area 2 funds on the Halcyon Realignment Project. Yet, the project keeps progressing. What does it take to stop the project?

This project was included in previous Traffic Model Reports as a Capital Improvement Project and as such was included as a specific generator of traffic mitigation fees. Perhaps the 2.5M\$ of traffic mitigation fees designated for this realignment could be loaned to the Willow Project. Motion made by Marianne Buckmeyer and seconded by Jeanne Taylor that committee send a rep to December 12 Board of Supervisors meeting to ask that Area 2 funds not be spent on the Halcyon Realignment. Request that 2.5M\$ be loaned to Willow Project. Motion passed unanimously.

9 Availability of the Haleyon Realignment Project origin/destination raw data for review. Was this test conducted in accordance with any nationally recognized engineering standards? If so please cite the standard. Shouldn't the TPG report be stamped and signed by an individual licensed to practice engineering in the State of California.

10 Request for an activity chart/timeline diagram of action items from the County covering November thru

May (6 months) on Willow Road activities.

Dale will get this information for the committee. Dale indicated that the environmental studies will be completed by June 2007 for the extension and December 2007 for the interchange. The next step will be acquisition of the right-of-way.
