Public Comment

There was a request for a driver feedback sign on Stanton. Michelle will pursue the purchase history of the sign. Near Pomeroy and Waypoint there are numerous overhanging Eucalyptus branches overhanging Pomeroy. These could be a threat to traffic. Concerns' were expressed about The stoplight proposal at Pomeroy and Willow and the inadequacy of turn lanes along Willow. Status of *No Parking* area in front of the Chevron station.

Old Business

- a) Request for rehab of Halcyon Road between SR-1 and Appaloosa Way. Scheduled for 2016.
- b) Update on South County Traffic Model. BOS will consider on November 25th
 - c) Update on Swap Meet Mary/Juniper changes.

Roadway width on Mary will increase from 2 lanes to 3 lanes as Mary approaches Juniper. At Juniper there will be a dedicated right turn lane and a dedicated left turn/straight lane. The intersection of Juniper and Mary will be provided an with an all way stop.

New Business

a) Speed bumps on Sequoia Lane/Humboldt Drive between Golden Leaf Lane and Cascade Lane.

Residents along Humboldt Drive petitioned for speed humps along Humboldt Drive. All criteria were met. During the meeting a show of hands indicated there were equal numbers of proponents and opponents. Petitions were presented by both sides. Convincing arguments were presented by both sides. The Council asked that both sides continue their petitioning efforts to include more of the affected residents and bring the results back to the next Traffic meeting.

b) There is a need for parking control on Ten Daks – the road width in minimal with a very bad sight distance problem. With cars parked on the side of the road northbound and southbound drivers are forced to the center of the road. With the limited sight distance numerous near misses have occurred

Public works will consider this after notification of the residents.

c) Has Public Works reviewed the plans for the proposed elder care center on Juniper in light of the swap meet traffic? What about transit needs?

This has not been reviewed, yet. RTA is responsible for transit issues.

- d) Request that Public Works remove several A-frame sign boards located on concrete walkway in front of the south side of 671 W. Tefft. Public Works will consider this issue.
 - e) A resident requests that a rehabilitation effort be made for Dana Street east of Thompson.

A work order will be submitted. This is a tier three road and it is not currently in the five-year plan. The plan consists of 202 miles of rehab needs for tier three roads. Public Works can only rehab 5 miles of roads per year.
